
Count 1 - A person is guilty of aggravated harassment in the second degree when: 2. with intent to harass or threaten another person, he or she makes a telephone call, whether or not a conversation ensues, with no purpose of legitimate communication.

To Wit: On the aforesaid date, time and place of occurrence the Defendant began calling 911 with no legitimate purpose in excess of approximately 300 times. During these calls, the Defendant would be verbally abusive to numerous Communications Bureau Operators, would not attempt to report any crime, and would continue calling with no legitimate purpose when informed that calling 911 is reserved for reporting emergencies and crimes. These calls continued between June 25, 2020 up until November 25, 2020. During these phone calls the Defendant identified himself as Mark Pine D.O.B 08/15/1976. Deponent was advised by other Detectives that Defendant was located at Jericho Public Library and placed under arrest. Defendant did admit to your deponent that he had been making calls to Nassau County 911.

The above is based on information and belief, the source of said information and the basis of said belief being the signed supporting depositions of Karen Brohm, Isabelle Minecci, and Kristen Saciolo, which are annexed heretofore and made a part hereof, the phone calls made to Communications Bureau, screenshots from the Defendant's instagram account, and the Defendant's oral admissions made to your Deponent.

Any false statements made herein are punishable as a class A misdemeanor pursuant to Section 210.45 of the Penal Law, and as other crimes.

These calls have unnecessarily wasted time for our operators and have become an annoyance and a nuisance for the workers in the Communications Bureau. I did not give anybody permission to continually call Communications Bureau with no legitimate purpose and I am requesting an arrest. This statement has been prepared for me by Det.
